

Sanjeev kumar flat No.330, Sh Deepak Sachdeva flat No.428 Sh Vinod kumar Yadav flat No. 446 Proposed the name of Capt Satbeer Singh resident of flat No. 270 as election officer.

GS asked to Capt. Satbeer Singh Sir are you willing to conduct the RWA elections. He said if nobody is ready to do so, I am the last option, he also proposed the name of Sh.
